#### Terms of Agreement:

1. This loan agreement is for one Alpha-Stim<sup>®</sup> M or one Alpha-Stim<sup>®</sup> AID to Recipient for a period of 60 days.
2. The Alpha-Stim<sup>®</sup> device covered by this agreement will be shipped to Recipient in good condition from EPII and remains EPII's property with assurance of EPII's right of recovery with or without due process of law until the device is returned in good condition to EPII or purchased under the terms and conditions of this agreement. If device is not received by EPII within 60 days of the date shipped to Recipient, the Recipient's credit card will be charged and the device considered purchased by Recipient. *There is no grace period.*
3. The Recipient acknowledges that the Alpha-Stim<sup>®</sup> device hereby loaned is for the Recipient's sole benefit and in the event of loss of or damage to the device or the theft or destruction of the device, the Recipient shall be liable to and shall immediately pay EPII the amount indicated above at the time of loss, damage or theft.
4. Device is shipped freight prepaid to recipient. All duties and taxes are to be paid by recipient and return freight is recipient's responsibility if device is returned to EPII. Freight charges are the responsibility of the recipient if the device is purchased at the end of the loan period.
5. The Recipient agrees to exercise normal care in the handling and operation of the Alpha-Stim<sup>®</sup> device.
